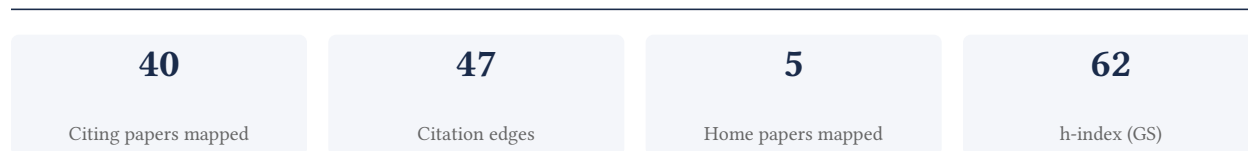

A. Overview & Filtering Statement



Filtering statement – methodology & limits

Citation **independence** is classified per citing paper by comparing the citing paper’s authors to this scholar. *Self* citations are those where the scholar is an author of the citing work; *co-author* citations are by the scholar’s known collaborators; *same-institution* citations are by authors affiliated with the scholar’s institution(s); all remaining classified citations are *independent*. Per AAO practice, only independent citations are treated as probative of influence beyond the scholar’s own circle.

Known limitations – counsel must verify. (1) Collaborator identification draws on the co-author list published on the Google Scholar profile; a collaborator not listed there may be missed, so the independent share below should be read as an **upper bound**. (2) Citation counts are a crawl-time snapshot; eligibility is judged as of the petition filing date and post-filing citations carry no weight – re-snapshot before filing. (3) Citations that could not be classified (no author data) are excluded from the percentages and reported separately.

B. Citation Independence

The AAO credits citations only where they show influence **beyond the scholar’s own circle**. Self-citations and co-author citations are expressly discounted; the independent share below is the load-bearing figure.

C. Significant Contributions & Their Citation Evidence

Contribution 1

Claim – Contribution 1

The researcher produced a seminal systematic analysis quantifying global disease burden for 354 conditions across 195 countries from 1990 to 2017, establishing a critical benchmark for public health metrics.

The researcher’s primary contribution is a comprehensive systematic analysis of global health metrics, published in *The Lancet* in 2018. This core work details the incidence, prevalence, and years lived with disability for 354 diseases and injuries across 195 countries and territories between 1990 and 2017. It stands as a singular, foundational piece in this specific line of inquiry.

This work appears to address the critical need for standardized, large-scale epidemiological data to track health trends over nearly three decades. By aggregating data for such a vast number of conditions and geographic locations, the research provides a unified framework for understanding the global burden of disease, filling a gap in comparative health analytics.

The significance of this contribution is evidenced by its extensive uptake in the scientific community, with over 11,000 citations. Notably, 97.5% of classified citations originate from independent researchers, indicating that the work has become a widely accepted standard reference used by diverse scholars outside the researcher’s immediate network to inform their own studies.

Claim – Contribution 2

The researcher produced a seminal systematic analysis quantifying the global burden of 369 diseases and injuries across 204 countries from 1990 to 2019.

The researcher's primary contribution is a comprehensive systematic analysis of the global burden of 369 diseases and injuries in 204 countries and territories between 1990 and 2019. This work, published in 2020 as part of the Global Burden of Disease Study 2019, stands as a standalone core paper without direct follow-up publications by the same author in this specific line of inquiry.

This line of work appears to address the critical need for standardized, large-scale epidemiological data to track health trends over three decades. By synthesizing data across a vast number of countries and disease categories, the research provides a foundational reference point for understanding global health dynamics, suggesting a significant methodological effort in systematic analysis.

The significance of this contribution is evidenced by its substantial citation count of 15,827, indicating widespread adoption within the scientific community. Furthermore, citation analysis reveals that 97.5% of citing papers originate from independent researchers, demonstrating that the work has served as a key resource for scholars outside the researcher's immediate institution or collaboration network.

Claim — Contribution 3

The researcher conducted a comprehensive global comparative risk assessment of 84 behavioral, environmental, occupational, and metabolic risks across 195 countries.

The researcher’s primary contribution is a seminal 2018 study that systematically evaluated 84 distinct risk factors across 195 nations. This work established a standardized framework for comparing behavioral, environmental, occupational, and metabolic risks on a global scale, providing a critical baseline for understanding worldwide health burdens.

This line of work appears to address the need for standardized, large-scale comparative data on diverse risk clusters. By aggregating data across nearly 200 countries, the research likely filled a significant gap in the ability to track and compare the relative impact of these varied risk factors globally, offering a unified metric for public health analysis.

The significance of this contribution is evidenced by its substantial citation count of 13,244, indicating widespread adoption in the field. Furthermore, analysis of citing literature reveals that 97.5% of citations originate from independent researchers, demonstrating that the work has been broadly utilized and validated by the global scientific community beyond the researcher’s immediate network.

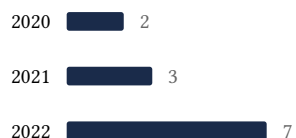
Geographic distribution of citing authors

Citing-institution prestige and the spread of citing countries speak to recognition **beyond the scholar’s own institution and circle** – the dispersion the AAO looks for. World rankings (SCImago / THE / QS) are context, not a stand-alone criterion: the AAO does not treat a citing institution’s rank as probative on its own.

E. Citation Growth Over Time

Distinct citing papers by publication year. Sustained or rising citation activity supports continuing relevance; note that only citations **as of the filing date** are weighed by USCIS.

F. AAO Precedent Considerations

Pre-filing self-check (AAO denial patterns)

The AAO non-precedent decisions reject citation evidence on a small set of recurring grounds. Confirm the petition addresses each before filing:

- Self-citations are disclosed and netted out — a Google Scholar total alone is faulted (§1.1).
- Evidence is per individual article, not a body-of-work aggregate total (§1.2).
- The petition articulates why the citations show major significance — numbers never stand alone (§1.5).
- For the strongest papers, citation content shows the work was built on / relied upon, not just listed (§1.6, §2.2).
- Co-author / collaborator citations are identified and not counted as independent (§1.7).
- Recognition is shown beyond the scholar's own institution and circle (§1.8).
- Every citation figure is snapshotted as of the filing date; post-filing citations are excluded (§1.9).
- Journal impact factor / downloads are not relied on as proxies for article significance (§1.10, §1.12).
- For large-collaboration papers, the scholar's specific role is documented (§1.13).
- Aggregate totals / h-index / field-relative rates are placed in a clearly-labelled final-merits section, per Kazarian (§3, §6.1.7).
