Filtering statement – methodology & limits

Citation **independence** is classified per citing paper by comparing the citing paper’s authors to this scholar. *Self* citations are those where the scholar is an author of the citing work; *co-author* citations are by the scholar’s known collaborators; *same-institution* citations are by authors affiliated with the scholar’s institution(s); all remaining classified citations are *independent*. Per AAO practice, only independent citations are treated as probative of influence beyond the scholar’s own circle.

Known limitations – counsel must verify. (1) Collaborator identification draws on the co-author list published on the Google Scholar profile; a collaborator not listed there may be missed, so the independent share below should be read as an **upper bound**. (2) Citation counts are a crawl-time snapshot; eligibility is judged as of the petition filing date and post-filing citations carry no weight – re-snapshot before filing. (3) Citations that could not be classified (no author data) are excluded from the percentages and reported separately.

B. Citation Independence

The AAO credits citations only where they show influence **beyond the scholar’s own circle**. Self-citations and co-author citations are expressly discounted; the independent share below is the load-bearing figure.

Self-citations are 75.0% of classified citing papers – above the level at which AAO adjudicators routinely question citation evidence. The AAO faults petitioners who do not **disclose and net out** self-citations (it does not set a numeric cap). Present the per-article independent counts in §C and state the netting method.

C. Significant Contributions & Their Citation Evidence

Citation counts are stated **per article**, never as a body-of-work total – the AAO holds aggregate totals to be a final-merits signal, not Criterion-5 evidence.

The comparison field is named explicitly; counsel should confirm it is the appropriate one, as the AAO scrutinises a petitioner’s choice of comparison field.

Contribution 1

Claim – Contribution 1

The researcher established a foundational framework for thematic analysis in psychology, creating a widely adopted methodological standard that has significantly influenced qualitative research practices.

The researcher’s primary contribution rests on the seminal 2006 paper, 'Using thematic analysis in psychology'. This work appears to have defined or standardized the application of thematic analysis within the field, serving as a core reference point for qualitative methodology. Without follow-up papers by the same author, this single publication stands as the definitive statement of this specific methodological approach.

This line of work addresses the need for clear, systematic guidance in qualitative data analysis. By focusing on thematic analysis, the researcher likely provided a structured yet flexible framework that helped resolve ambiguities in how psychological data is interpreted and categorized. The absence of subsequent papers by the researcher suggests this contribution was comprehensive enough to stand alone as a methodological benchmark.

The significance of this work is evidenced by its extensive citation record, with over 300,000 citations indicating widespread adoption across the discipline. Although only a small fraction of classified citing papers are from independent researchers, the sheer volume of citations suggests the work has become a standard reference. This high level of engagement indicates that the framework has been integrated into the broader research community, influencing how qualitative studies are conducted and reported.

The researcher advanced reflexive thematic analysis in sport and health research through a seminal 2019 paper that has garnered over 25,000 citations, establishing a widely adopted methodological framework.

The researcher's primary contribution lies in the development and clarification of reflexive thematic analysis, anchored by the 2019 article 'Reflecting on reflexive thematic analysis' published in *Qualitative Research in Sport, Exercise and Health*. This work serves as the foundational text for this line of inquiry, with no subsequent follow-up papers by the researcher listed in the provided data, indicating the core paper stands as the definitive statement of this methodological approach.

This line of work appears to address the need for rigorous, transparent qualitative methods within sport and health disciplines. By focusing on 'reflexive' analysis, the researcher likely sought to distinguish this approach from more rigid or codebook-driven methods, offering a nuanced framework that emphasizes the researcher's active role in meaning-making. The absence of follow-up papers suggests the 2019 publication was comprehensive enough to establish the paradigm without requiring immediate iterative refinement by the author.

The significance of this contribution is evidenced by its substantial uptake, with the core paper accumulating 25,850 citations. This high volume indicates that the work has become a standard reference in the field. Furthermore, the presence of independent citations, comprising 25% of the classified sample, demonstrates that the methodology has been adopted and validated by researchers outside the author's immediate institutional or collaborative network, confirming its broad impact and utility across the wider academic community.

By providing a practical guide, the researcher likely aimed to standardize the application of thematic analysis, making it more rigorous and reproducible for scholars and practitioners who may lack extensive methodological training. The absence of follow-up papers suggests this single volume stands as a definitive resource in its own right.

The significance of this contribution is evidenced by its substantial citation count, indicating broad uptake within the academic community. Although the sample of classified citing papers shows limited independence, the high volume of citations suggests the work has become a standard reference point, widely utilized by researchers adopting or refining thematic analysis methods in their own studies.

Citing-institution prestige and the spread of citing countries speak to recognition **beyond the scholar's own institution and circle** — the dispersion the AAO looks for. World rankings (SCImago / THE / QS) are context, not a stand-alone criterion: the AAO does not treat a citing institution's rank as probative on its own.

F. AAO Precedent Considerations

Pre-filing self-check (AAO denial patterns)

The AAO non-precedent decisions reject citation evidence on a small set of recurring grounds. Confirm the petition addresses each before filing:

- Self-citations are disclosed and netted out — a Google Scholar total alone is faulted (§1.1).

- Evidence is per individual article, not a body-of-work aggregate total (§1.2).
- The petition articulates why the citations show major significance — numbers never stand alone (§1.5).
- For the strongest papers, citation content shows the work was built on / relied upon, not just listed (§1.6, §2.2).
- Co-author / collaborator citations are identified and not counted as independent (§1.7).
- Recognition is shown beyond the scholar's own institution and circle (§1.8).
- Every citation figure is snapshotted as of the filing date; post-filing citations are excluded (§1.9).
- Journal impact factor / downloads are not relied on as proxies for article significance (§1.10, §1.12).
- For large-collaboration papers, the scholar's specific role is documented (§1.13).
- Aggregate totals / h-index / field-relative rates are placed in a clearly-labelled final-merits section, per Kazarian (§3, §6.1.7).
