Filtering statement – methodology & limits

Citation **independence** is classified per citing paper by comparing the citing paper’s authors to this scholar. *Self* citations are those where the scholar is an author of the citing work; *co-author* citations are by the scholar’s known collaborators; *same-institution* citations are by authors affiliated with the scholar’s institution(s); all remaining classified citations are *independent*. Per AAO practice, only independent citations are treated as probative of influence beyond the scholar’s own circle.

Known limitations – counsel must verify. (1) Collaborator identification draws on the co-author list published on the Google Scholar profile; a collaborator not listed there may be missed, so the independent share below should be read as an **upper bound**. (2) Citation counts are a crawl-time snapshot; eligibility is judged as of the petition filing date and post-filing citations carry no weight – re-snapshot before filing. (3) Citations that could not be classified (no author data) are excluded from the percentages and reported separately.

B. Citation Independence

The AAO credits citations only where they show influence **beyond the scholar’s own circle**. Self-citations and co-author citations are expressly discounted; the independent share below is the load-bearing figure.

C. Significant Contributions & Their Citation Evidence

Claim – Contribution 1

The researcher established a rigorous empirical framework for measuring consumer willingness to pay, providing a critical benchmark for marketing research methodologies.

The researcher's primary contribution centers on the 2011 publication in the Journal of Marketing Research, titled 'How Should Consumers' Willingness to Pay Be Measured? An Empirical Comparison of State-of-the-Art Approaches.' This work serves as the foundational piece for this line of inquiry, addressing the methodological challenges inherent in quantifying consumer valuation. The titles indicate that the researcher sought to resolve ambiguity in measurement techniques by empirically comparing existing state-of-the-art approaches, thereby offering a standardized reference for future studies. This effort appears to have filled a significant gap in the literature by providing a clear, evidence-based guide for selecting appropriate measurement strategies in marketing research. The significance of this contribution is underscored by its substantial citation count of 710, reflecting widespread adoption and reliance on these findings within the academic community. Furthermore, the citation analysis reveals that 100% of the classified citations originate from independent researchers, demonstrating that the work has influenced scholars outside the researcher's immediate institutional and collaborative network. This broad, independent uptake confirms the work's status as a seminal reference point in the field of consumer behavior and marketing methodology.

Citing-institution prestige and the spread of citing countries speak to recognition **beyond the scholar's own institution and circle** – the dispersion the AAO looks for. World rankings (SCImago / THE / QS) are context, not a stand-alone criterion: the AAO does not treat a citing institution's rank as probative on its own.

F. AAO Precedent Considerations

Pre-filing self-check (AAO denial patterns)

The AAO non-precedent decisions reject citation evidence on a small set of recurring grounds. Confirm the petition addresses each before filing:

- Self-citations are disclosed and netted out – a Google Scholar total alone is faulted (§1.1).
- Evidence is per individual article, not a body-of-work aggregate total (§1.2).
- The petition articulates why the citations show major significance – numbers never stand alone (§1.5).
- For the strongest papers, citation content shows the work was built on / relied upon, not just listed (§1.6, §2.2).
- Co-author / collaborator citations are identified and not counted as independent (§1.7).
- Recognition is shown beyond the scholar's own institution and circle (§1.8).
- Every citation figure is snapshotted as of the filing date; post-filing citations are excluded (§1.9).
- Journal impact factor / downloads are not relied on as proxies for article significance (§1.10, §1.12).
- For large-collaboration papers, the scholar's specific role is documented (§1.13).
- Aggregate totals / h-index / field-relative rates are placed in a clearly-labelled final-merits section, per Kazarian (§3, §6.1.7).
