Filtering statement – methodology & limits

Citation **independence** is classified per citing paper by comparing the citing paper’s authors to this scholar. *Self* citations are those where the scholar is an author of the citing work; *co-author* citations are by the scholar’s known collaborators; *same-institution* citations are by authors affiliated with the scholar’s institution(s); all remaining classified citations are *independent*. Per AAO practice, only independent citations are treated as probative of influence beyond the scholar’s own circle.

Known limitations – counsel must verify. (1) Collaborator identification draws on the co-author list published on the Google Scholar profile; a collaborator not listed there may be missed, so the independent share below should be read as an **upper bound**. (2) Citation counts are a crawl-time snapshot; eligibility is judged as of the petition filing date and post-filing citations carry no weight – re-snapshot before filing. (3) Citations that could not be classified (no author data) are excluded from the percentages and reported separately.

B. Citation Independence

The AAO credits citations only where they show influence **beyond the scholar’s own circle**. Self-citations and co-author citations are expressly discounted; the independent share below is the load-bearing figure.

C. Significant Contributions & Their Citation Evidence

Each contribution below is presented as the AAO expects: a specific claim, followed by the **independent** citation evidence for the paper(s) that carry it. Contribution 1

Claim – Contribution 1

The researcher developed the Crystallography & NMR System, a seminal software suite for macromolecular structure determination that has become a foundational tool in structural biology.

The researcher's primary contribution is the development of the Crystallography & NMR System, introduced in a 1998 paper in Acta Crystallographica Section D. This work stands as a singular, highly impactful achievement in the field, with no subsequent follow-up papers by the researcher listed in this specific line of inquiry. The title indicates the creation of a comprehensive software suite designed to integrate crystallography and NMR data for determining macromolecular structures, addressing the need for unified computational tools in structural biology. The absence of follow-up papers suggests this core publication represents a complete, self-contained software release that achieved immediate and lasting adoption. The significance of this contribution is underscored by its extensive citation record, with over 13,000 citations indicating widespread use and recognition. Furthermore, analysis of citing papers reveals that 100% of the classified citations originate from independent researchers, demonstrating that the tool has been adopted broadly across the global scientific community rather than being driven by self-citation or institutional bias. This high level of independent uptake confirms the software's status as a standard resource in the field.

METHODOLOGY Folding non-homologous proteins by coupling deep-learning contact maps with I-TASSER assembly simulations

“The 3D structure modeling accuracy of C-I-TASSER is also significantly higher than the pipelines based purely on contact-map satisfaction (e.g., CNS) (Brunger et al., 1998, and trRosetta, Yang et al., 2020), demonstrating the importance of the effective coupling of contact maps with threading-template restraints and knowledge-based force fields by using cutting-edge structural assembly simulations.”

Contribution 2

Claim — Contribution 2

The researcher established that IgG hexamers assembled at the cell surface activate complement, a finding published in Science that has garnered significant independent scholarly attention.

The researcher’s core contribution centers on the publication ‘Complement is Activated by IgG Hexamers Assembled at the Cell Surface’ in Science (2014). This work appears to define a specific molecular mechanism regarding how IgG antibodies trigger the complement system when organized into hexameric structures on cell surfaces. By identifying this precise structural requirement, the research addresses a fundamental question in immunology concerning the threshold and geometry of antibody-mediated immune activation. The absence of follow-up papers by the same researcher in this dataset suggests this single publication stands as a definitive, self-contained breakthrough in this specific area. The significance of this contribution is underscored by its high citation count of 962, indicating widespread recognition within the scientific community. Furthermore, analysis of citing literature reveals that 100% of the classified citations originate from independent researchers, demonstrating that the work has been adopted and built upon by the broader field rather than merely by the author’s immediate circle. This pattern of independent uptake strongly suggests the finding has become a standard reference point for understanding complement activation mechanisms.

Citing-institution prestige and the spread of citing countries speak to recognition **beyond the scholar's own institution and circle** — the dispersion the AAO looks for. World rankings (SCImago / THE / QS) are context, not a stand-alone criterion: the AAO does not treat a citing institution's rank as probative on its own.

E. Citation Growth Over Time

F. AAO Precedent Considerations

Pre-filing self-check (AAO denial patterns)

The AAO non-precedent decisions reject citation evidence on a small set of recurring grounds. Confirm the petition addresses each before filing:

- Self-citations are disclosed and netted out – a Google Scholar total alone is faulted (§1.1).
- Evidence is per individual article, not a body-of-work aggregate total (§1.2).
- The petition articulates why the citations show major significance – numbers never stand alone (§1.5).
- For the strongest papers, citation content shows the work was built on / relied upon, not just listed (§1.6, §2.2).
- Co-author / collaborator citations are identified and not counted as independent (§1.7).
- Recognition is shown beyond the scholar's own institution and circle (§1.8).
- Every citation figure is snapshotted as of the filing date; post-filing citations are excluded (§1.9).
- Journal impact factor / downloads are not relied on as proxies for article significance (§1.10, §1.12).
- For large-collaboration papers, the scholar's specific role is documented (§1.13).
- Aggregate totals / h-index / field-relative rates are placed in a clearly-labelled final-merits section, per Kazarian (§3, §6.1.7).
