Filtering statement – methodology & limits

Citation **independence** is classified per citing paper by comparing the citing paper’s authors to this scholar. *Self* citations are those where the scholar is an author of the citing work; *co-author* citations are by the scholar’s known collaborators; *same-institution* citations are by authors affiliated with the scholar’s institution(s); all remaining classified citations are *independent*. Per AAO practice, only independent citations are treated as probative of influence beyond the scholar’s own circle.

Known limitations – counsel must verify. (1) Collaborator identification draws on the co-author list published on the Google Scholar profile; a collaborator not listed there may be missed, so the independent share below should be read as an **upper bound**. (2) Citation counts are a crawl-time snapshot; eligibility is judged as of the petition filing date and post-filing citations carry no weight – re-snapshot before filing. (3) Citations that could not be classified (no author data) are excluded from the percentages and reported separately.

B. Citation Independence

The AAO credits citations only where they show influence **beyond the scholar’s own circle**. Self-citations and co-author citations are expressly discounted; the independent share below is the load-bearing figure.

C. Significant Contributions & Their Citation Evidence

The researcher developed a growth algorithm to precisely determine the critical percolation threshold for the three-dimensional Swiss cheese model, establishing a foundational computational benchmark in the field.

The researcher's significant contribution centers on the 2001 publication in *The Journal of Chemical Physics*, which introduced a growth algorithm for the precise determination of the critical percolation threshold in the three-dimensional Swiss cheese model. This work stands as a core achievement, with no subsequent follow-up papers by the same researcher listed in this specific line of inquiry, suggesting the original paper itself constitutes the primary methodological advance.

This line of work appears to address the computational challenge of accurately modeling percolation thresholds in complex three-dimensional porous media. By employing a specialized growth algorithm, the researcher likely provided a more rigorous or efficient approach to calculating these critical values compared to prior methods, thereby offering a reliable standard for studying transport properties in disordered systems.

The significance of this contribution is evidenced by its substantial citation count of 276, indicating that the method or results have been widely adopted by the scientific community. Furthermore, the citation analysis reveals that 100% of the classified citations originate from independent researchers, underscoring the work's broad impact and acceptance beyond the researcher's immediate institutional or collaborative network.

The S2 column flags citations Semantic Scholar identifies as *influential* — ones that substantively build on the work (S2's *isInfluential* signal, Valenzuela et al. 2015) — the “built on / relied upon” pattern the AAO credits. Citing-institution prestige and the spread of citing countries speak to recognition **beyond the scholar's own institution and circle** – the dispersion the AAO looks for. World rankings (SCImago / THE / QS) are context, not a stand-alone criterion: the AAO does not treat a citing institution's rank as probative on its own.

F. AAO Precedent Considerations

Pre-filing self-check (AAO denial patterns)

The AAO non-precedent decisions reject citation evidence on a small set of recurring grounds. Confirm the petition addresses each before filing:

- Self-citations are disclosed and netted out – a Google Scholar total alone is faulted (§1.1).
- Evidence is per individual article, not a body-of-work aggregate total (§1.2).
- The petition articulates why the citations show major significance – numbers never stand alone (§1.5).
- For the strongest papers, citation content shows the work was built on / relied upon, not just listed (§1.6, §2.2).
- Co-author / collaborator citations are identified and not counted as independent (§1.7).
- Recognition is shown beyond the scholar's own institution and circle (§1.8).
- Every citation figure is snapshotted as of the filing date; post-filing citations are excluded (§1.9).
- Journal impact factor / downloads are not relied on as proxies for article significance (§1.10, §1.12).
- For large-collaboration papers, the scholar's specific role is documented (§1.13).
- Aggregate totals / h-index / field-relative rates are placed in a clearly-labelled final-merits section, per Kazarian (§3, §6.1.7).
