### Filtering statement – methodology & limits

Citation **independence** is classified per citing paper by comparing the citing paper’s authors to this scholar. *Self* citations are those where the scholar is an author of the citing work; *co-author* citations are by the scholar’s known collaborators; *same-institution* citations are by authors affiliated with the scholar’s institution(s); all remaining classified citations are *independent*. Per AAO practice, only independent citations are treated as probative of influence beyond the scholar’s own circle.

**Known limitations – counsel must verify.** (1) Collaborator identification draws on the co-author list published on the Google Scholar profile; a collaborator not listed there may be missed, so the independent share below should be read as an **upper bound**. (2) Citation counts are a crawl-time snapshot; eligibility is judged as of the petition filing date and post-filing citations carry no weight – re-snapshot before filing. (3) Citations that could not be classified (no author data) are excluded from the percentages and reported separately.

## B. Citation Independence

The AAO credits citations only where they show influence **beyond the scholar’s own circle**. Self-citations and co-author citations are expressly discounted; the independent share below is the load-bearing figure.

## C. Significant Contributions & Their Citation Evidence

## Contribution 1

### Claim – Contribution 1

*The researcher established theoretical consistency guarantees for spectral clustering within stochastic block models, providing a rigorous statistical foundation for community detection in network analysis.*

**CLAIM:** The researcher’s primary contribution is the establishment of theoretical consistency for spectral clustering in stochastic block models, as demonstrated in their 2015 paper published in *The Annals of Statistics*. This work serves as the foundational pillar for this line of inquiry, with no subsequent follow-up papers by the researcher listed in the provided data.

**ORIGINALITY:** The title suggests the work addresses a critical gap in the statistical validation of spectral clustering methods. By focusing on stochastic block models, the researcher appears to have provided rigorous theoretical assurances for a widely used algorithm, moving beyond heuristic application to formal statistical consistency.

**SIGNIFICANCE:** With 908 citations, this paper is highly influential in the field. The citation analysis indicates that 100% of the classified citing papers originate from independent researchers, suggesting broad adoption and validation of the researcher’s theoretical framework by the wider academic community.

Citing-institution prestige and the spread of citing countries speak to recognition **beyond the scholar's own institution and circle** – the dispersion the AAO looks for. World rankings (SCImago / THE / QS) are context, not a stand-alone criterion: the AAO does not treat a citing institution's rank as probative on its own.

## F. AAO Precedent Considerations

### Pre-filing self-check (AAO denial patterns)

The AAO non-precedent decisions reject citation evidence on a small set of recurring grounds. Confirm the petition addresses each before filing:

- Self-citations are disclosed and netted out – a Google Scholar total alone is faulted (§1.1).
- Evidence is per individual article, not a body-of-work aggregate total (§1.2).
- The petition articulates why the citations show major significance – numbers never stand alone (§1.5).
- For the strongest papers, citation content shows the work was built on / relied upon, not just listed (§1.6, §2.2).
- Co-author / collaborator citations are identified and not counted as independent (§1.7).
- Recognition is shown beyond the scholar's own institution and circle (§1.8).
- Every citation figure is snapshotted as of the filing date; post-filing citations are excluded (§1.9).
- Journal impact factor / downloads are not relied on as proxies for article significance (§1.10, §1.12).
- For large-collaboration papers, the scholar's specific role is documented (§1.13).
- Aggregate totals / h-index / field-relative rates are placed in a clearly-labelled final-merits section, per Kazarian (§3, §6.1.7).
